

TERMS OF SERVICE

Intro

These terms of service ('ToS') govern your access to and use of the services ('Services') provided by Wedao through its website wedao.art or other communication platforms (such as applications on mobile devices). Wedao.com is owned and operated by Wedao, d.o.o. (Wedao). The Services may only be accessed in accordance with these ToS and Wedao's Privacy Policy. Any violation of these ToS may be enforced by Wedao to the fullest extent allowed by law.

By accessing the Services, you represent and warrant that you have the right, authority, and capacity to use our Services and to abide by all of the terms and conditions herein. Access to and use of the Services is prohibited to persons under 16. If you are an individual using the Services on behalf of an entity, you represent and warrant that you have all necessary right and authority to bind such entity to the terms and conditions of these ToS. By accessing the Services, you agree to be bound by these ToS.

These ToS may be changed, revised or amended by Wedao at its own discretion. If material changes to the ToS are made, they will be posted on Wedao.com under the section 'Terms of Service' and effective upon posting. Accounts
